CONSENT ORDER

The Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois, by Vladimir Lozovskiy, one of its attorneys, (hereinafter the "Department") and Jonathan C. Gamze, M.D., (hereinafter the "Petitioner"), hereby agree to the following:

STIPULATIONS

Jonathan C. Garnze, M.D. is licensed as a Physician and Surgeon in the State of Illinois, holding Illinois Physician and Surgeon License No. 036-078450 and Illinois Controlled Substance License No. Since September 14, 2015, Petitioner's Illinois Physician and Surgeon License is on Indefinite Probation for a minimum of three (3) years and Petitioner's Illinois Controlled Substance License is on Indefinite Suspension for his failure to properly prescribe medications and assess a patient with a history of mental illness and addiction disorders. At all times material to the matter(s) set forth in this Consent Order, the Department of Financial and Professional Regulation, Division of Professional Regulation, of the State of Illinois had jurisdiction over the subject matter and parties herein.

In 2015, Petitioner filed a Petition for Restoration of his Illinois Controlled Substance License with various supporting documents. As a result of the Petition, a Formal Hearing was set to commence on June 29, 2017 when the Department and Petitioner, through his attorney Jacqueline F. Stein, engaged in negotiations for an amicable resolution for the pending Petition to Restore Petitioner's Illinois Controlled Substance License.

Petitioner has been advised of the right to a hearing on his Petition for Restoration and the right to Administrative Review of any Order resulting from a hearing. Petitioner knowingly waives each of these rights, as well as any right to administrative review of this Consent Order. Such waiver ceases if this Consent Order is rejected by either the Director or the Medical Disciplinary Board. Petitioner acknowledges that he has freely and willfully entered into this Consent Order without any threat or coercion by any person. Petitioner has not relied upon any representation by or on behalf of the Department other than those set forth herein.

The Petitioner and the Department have agreed, in order to resolve this matter to allow Petitioner, Jonathan C. Gamze, M.D., to enter into a Consent Order with the Department, providing for the restoration of his Illinois Controlled Substance license at this time.

CONDITIONS

WHEREFORE, the Department, through Vladimir Lozovskiy, its attorney, and Jonathan C. Gamze, M.D., Petitioner, through his attorney Jacqueline F. Stein, agree:

A. Illinois Physician and Surgeon License of Jonathan C. Gamze, M.D., license No. 036-078450 will remain on indefinite probation which is now extended to a total of 54 (fifty-four) months dating back to September 14, 2015. Petitioner agrees that he will not be eligible to file a Petition for Restoration of his Illinois Physician and Surgeon License until he is able to show a proof that he has obtained his DEA Registration without any restrictions and/or agreement with the U.S. Department of Justice, Drug Enforcement Administration;

- B. Illinois Controlled Substance License of Jonathan C. Gamze, M.D., License No.
 - is restored to active status upon the final approval of this Consent Order by the

Director of the Division of Professional Regulation;

C. While Petitioner's Illinois Physician and Surgeon License is on Probation,

Petitioner shall provide the Department with quarterly reports which include: (i) current residential address and contact telephone number as well as current practice location address and contact telephone number; (ii) address and contact information for each healthcare entity where Petitioner has admitting privileges and/or employed; (iii) description of job duties, responsibilities and name of immediate supervisor and/or Department's Chairperson; (iv) copy of any and all incident reports within the prior quarter filled against Petitioner; and (v) information, regarding any arrests, criminal, or civil actions filed, including DUI and/or other similar offenses against the Petitioner;

- D. While Petitioner's Illinois Physician and Surgeon License is on Probation, Petitioner shall notify the Department's Chief of Probation Investigations in writing of any change in employment and/or home address and/or telephone number within ten (10) days;
- E. While Petitioner's Illinois Physician and Surgeon License is on Probation, Petitioner shall not treat and/or prescribe any medications for any of his family members and friends;
- F. While Petitioner's Illinois Physician and Surgeon License is on Probation, Petitioner shall request the Department's Chairperson from any health-care institution(s), where Petitioner is holding admitting privileges, to submit quarterly reports to the Department regarding Petitioner's clinical performance, attendance record and any and all other issues arising out of Petitioner's practice of medicine;
- G. While Petitioner's Illinois Physician and Surgeon License is on Probation, Petitioner shall continue to utilize a service of a practice monitor, who is a licensed Physician and Surgeon in

the State of Illinois. Said practice monitor cannot be affiliated with Petitioner's practice. Said practice monitor shall have an unrestricted Illinois Physician and Surgeon License that has never been disciplined by any state and/or federal agencies. The practice monitor shall be hired at the expense of Petitioner and shall be pre-approved by the Chief Medical Coordinator of the Department. Petitioner shall request that his practice monitor submit quarterly reports about scope and performance appraisals. On a quarterly basis the practice monitor shall meet with Petitioner and randomly select and review ten (10) charts of patients who have been seen by Petitioner during the quarter. The practice monitor shall review the charts of those patients and submit independent quarterly reports to the Department evaluating the scope, appropriateness, and quality of medical care rendered by Petitioner as well as review Petitioner's compliance with the terms and conditions of this Consent Order. Petitioner agrees to provide a copy of this Consent Order to his practice monitor within 30 days of the final approval of this Consent Order;

- H. The practice monitor shall agree to inform the Department immediately if there is evidence of inappropriate behavior, professional misconduct, a violation of Petitioner's probation or any violation of the laws and rules governing the practice of medicine;
- Petitioner shall immediately notify the Department should his relationship with any practice monitor cease and immediately take actions to select a new monitor and obtain the approval of the Chief Medical Coordinator;
- J. While Petitioner's Illinois Physician and Surgeon License is on Probation, Petitioner agrees to the following conditions related to his Controlled Substance prescribing:
 - Petitioner shall not prescribe any opiates/narcotics/pain medications except as set forth below in J(ii).
 - ii. Petitioner shall only prescribe Buprenorphine for treatment of addiction;

- iii. Petitioner shall limit prescribing of any Schedule II through V Controlled Substances to 1 prescription with 2 refills;
- iv. Petitioner shall not purchase, store and/or dispense any Controlled Substances from his office and shall not accept or maintain samples of any Controlled Substances in his office or private residence;
- v. Petitioner shall show a proof of completion of additional 20 Category I CME credits related to proper prescribing of Controlled Substances in the practice of psychiatry.
- K. All the reports required to be submitted under the terms of this Probation shall be filed with the Department no later than 1/20, 4/20, 7/20 and 10/20 of each year during the full term of the Probation.
- L. Petitioner agrees that a violation of the terms and conditions of this Consent Order or a violation of the terms of probation is a violation of 225 ILCS 60/22(A)(15);
- M. Petitioner shall not violate the Illinois Medical Practice Act of 1987, any other federal and state laws related to the practice of medicine.
- N. If Respondent violates any of the terms and conditions of this Order, the Director of the Division of Professional Regulation may issue an Order forthwith mandating the automatic, immediate, indefinite suspension of Petitioner's Illinois Physician License 036-078450 for a minimum of twelve (12) months. This indefinite suspension shall not preclude the Department from taking any other disciplinary or other actions it deems appropriate. In the event Petitioner contests in writing (by the filing of an appropriate petition with the Department) the factual basis underlying said indefinite suspension within thirty (30) days of the imposition thereof, then Petitioner shall be afforded a hearing on the merits within thirty (30) days from filing of said petition;

O. Upon the final approval of this Consent Order by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation, the Probation's terms and conditions set out by this Consent Order shall supersede the terms and conditions of the Probation in the IDFPR Consent Order No. 2013-10181-1 approved by the Director of the Division of Professional Regulation on September 14, 2015;

P. This Consent Order shall become effective immediately after it is approved by the Director of the Division of Professional Regulation of the Illinois Department of Financial and Professional Regulation.
